UBUD, BALI



Ubud is the cultural and spiritual center of Bali. The numerous villages that make up Ubud feature remarkable examples of traditional architecture and the town itself is still consumed by a gentle, peaceful and spiritual atmosphere. Balinese culture is at its strongest here with plenty of opportunities to immerse in ancient arts.

SEMINYAK, BALI



Seminyak is the effortlessly cool and dynamic region of Bali where world-class hotels rub shoulders with designer boutiques and long stretches of pearly-white sand. Days can be spent lounging in resplendent spas, admiring traditional Balinese ceremonies and soaking up the last rays of the sun as it fades behind the ocean.

KOMODO ISLAND



Komodo is easily accessible from Sumba and Flores by boat. Its charm lies in its undeveloped land, void of even a port with passengers taken by small boats the island's only village to clamber out onto its parched soil. Most visit to see the Komodo dragon in its natural habitat, with an estimated 5,000 Komodo Dragons spread across the islands of

Komodo, Rinca and Flores. At three meters in length and weighing as much as 136 kg, the Komodo is the largest and most powerful lizard on earth and totally unique to Indonesia.

JAVA

Java is a remarkable island with no less than 121 active volcanoes, a host of national parks and Borobudur, the world's largest Buddhist shrine. Tangkuban Perahu is a dormant volcano 30 km north of the city of Bandung, the provincial capital of West Java.



For those interested in cultural pursuits such as arts, crafts and exploring ancient temples and palaces, Yogyakarta is the place to visit. Referred to as 'Yogja' by the locals, this city is an incredible mix of old and new. Yogyakarta is also the gateway to the compelling Borobudur Temple, located just 25 km northwest from the city centre. Borobudur is the single largest Buddhist shrine anywhere on earth and those who visit will be amazed by both the scale of the structure and the

remarkable attention to detail. It is set in the heart of the verdant Kedu Plain which enhances the sense of awe and drama.

SINGAPORE



Singapore is often said to have its head in the future but its heart in the past. On arrival into this island country, visitors are struck by the dramatic contrast of charming well-preserved buildings of a bygone era, standing beside towering office buildings or developments on tree-lined boulevards. TERMS & CONDITIONS

NOTE: BY SENDING US YOUR INITIAL DEPOSIT (OR ANY SUBSEQUENT PAYMENT) TOWARD YOUR TRIP PRICE, YOU ARE CONFIRMING YOUR ACCEPTANCE OF THE TERMS & CONDITIONS BELOW.

PRICING AND PAYMENT

To confirm your itinerary, we collect a 30% deposit on the total trip price, or more if there are larger nonrefundable supplier amounts due (in some circumstances such as yacht or plane charter a larger non-refundable deposit may be required and separate terms will be drawn up). Please note that until we have received your deposit payment at the time of confirmation, all arrangements are *subject to availability and/or price change*. Final payment is due 90 days prior to the trip start date. Pricing is calculated on current exchange rates. Roam Travel Company (RTC) reserves the right to reprice if significant currency fluctuation takes place between the time of confirmation and full payment. If you would like to pay in full at the time of confirmation, RTC is able to fix the price at the rate offered. Payment can be made by credit card (Visa, MasterCard, American Express), personal check and bank transfer at this time. If final payment is not received, RTC reserves the right to release your reservations and assumes that the trip has been cancelled by you. In this instance, our standard cancellation fees would apply.

TRIP CANCELLATION

Your trip is subject to cancellation penalties depending on time of cancellation. If you cancel your trip, the following fees will apply:

61+ days prior to trip start=25% of trip price 0-60 days=100% of trip price

RTC retains the right to change or cancel your trip entirely in extreme circumstances, for example if your safety or the quality of the trip, in our sole opinion, is deemed to be compromised. If we cancel your trip, we will refund what you have paid us but we cannot be held responsible for losses you may incur with third parties, such as airlines or hotels. For this reason, we strongly recommend Cancellation & Interruption insurance.

TRAVEL INSURANCE

We strongly recommend that you purchase comprehensive travel insurance. Our cancellation fees are not negotiable.

UNFORESEEABLE CHANGES

It is sometimes necessary (or recommended) that changes be made to your itinerary after it has been confirmed with your deposit. This is most common when a third party (i.e. airline, hotel) makes changes that are beyond our control, such as a flight cancellation or schedule change. In other instances, changes may be necessary due to extreme weather or events in the region. We will always do our best to rework the itinerary in a way that minimizes changes to the flow and pricing of your trip. However, if the itinerary changes require us to re-price your trip you will be responsible for the difference in cost.

WHEN YOU MAKE CHANGES TO YOUR TRIP

Clients are allowed to make minor changes to the itinerary once the trip is confirmed, within reason as determined by RTC and with sufficient advance notice. We will try our best to accommodate your requests. However, major changes will incur additional planning fees and/or nonrefundable deposit payments in addition to the amount initially quoted. See the "Trip Cancellation" section above for our fees should you need to cancel your trip entirely.

YOUR RESPONSIBILITIES

RTC is committed to making your trip as rewarding and fun as possible. But we require your help to do so. For example, we rely on you to provide us with necessary personal information and travel preferences (fill-in forms will be provided) so we can craft the right trip for you. We also ask that you respond to our questions in a timely manner so as not to delay the planning process. It is your responsibility to become informed about the most current travel advisories and warnings for countries of travel. We will do our best to keep you informed of major developments but you must contact your relevant government agency to be aware of any travel advisories and warnings (U.S. Department of State-http://travel.state.gov/) Should you choose to ignore such travel advisories and warnings, the Traveler assumes all risk of personal injury, death or property damage that may arise out of the events like those advised or warned against.

OUR RESPONSIBILITIES

RTC recognizes the faith and trust you put in us to plan your travel. We will do our utmost to create and deliver the perfect trip for you. Our aim is to provide you with reliable and personalized service. We will respond to your messages promptly and will keep you informed as your itinerary evolves. If at any time you have questions or concerns we ask that you let us know immediately so we can address them.

TRAVEL DOCUMENTS AND PASSPORTS

It is your responsibility to ensure that you have a valid passport and meet all necessary entry requirements of the country or countries you will be visiting. These requirements vary by country and nationality and can change from time to time. RTC will do its best to inform Travelers of these general requirements, but we ask that you contact the appropriate embassy(ies)/consulate(s) in your country of residence. RTC is not responsible for delays, changes or costs of any kind due to incomplete, expired or inaccurate Traveler documentation.

HEALTH

By sending us your initial deposit you certify that you nor to your knowledge anyone travelling with you, if applicable, does not have any physical or other condition or disability that would make travelling unsafe for you or other Travelers. It is your responsibility to ensure that you have received all appropriate vaccinations and medications (Center for Disease Control and Prevention- http://www.cdc.gov/). Please consult your doctor before travelling with us and take all necessary precautions.

PRIVACY

Your privacy is important to us. RTC is required to collect personal information (such as passport details) in order to plan your trip. We appreciate the sensitive nature of this information and will not share it with third parties (other than as required for booking air, hotel or other reservations as a part of your trip). By sending us your initial deposit, you are consenting to RTC collecting and using your personal information as required to plan your trip and provide you with proper services.

RISKS

As always, travel involves risks. Our trips are often off the beaten path and in developing countries with transportation, communication and healthcare standards that are different from what you get at home. Our trips may be physically demanding and there is a risk of serious personal injury, including permanent disability and death from accident, illness or the actions of negligence of other persons. Medical facilities and services may not be readily accessible and may not be sophisticated. With that said, our local team in each country are available to provide an additional level of security in case of injury or disaster.

PHOTOGRAPHY

In participating in the trip, we ask that Travelers share rights to any photographic or film records of the trips for promotional and/or commercial purposes, without any remuneration to the Traveler. We appreciate your participation in this and hope that you appreciate our interest.

LIMITATION OF LIABILITY, RELEASE AND INDEMNITY

To be eligible to take a RTC trip, Travelers must accept the risks of travel, including those set out in "Risks" and otherwise set out in these Terms & Conditions, and assume full responsibility for any loss, injury, death or damage to them, their family or their dependents or property arising in connection with their participation, or the participation of their family, in the trip. Travelers must have their own insurance appropriate to their needs and the needs of their family or dependents in respect of such loss, injury, death or damage.

The cost of all RTC trips is based on Travelers agreeing to these Terms & Conditions and in particular this Limitation of Liability, Release and Indemnity. As RTC is acting solely as an agent of you with respect to all transportation, accommodations, meals and other arrangements, in consideration for participating in the trips, Travelers agree not to sue Roam Travel Company, its employees, directors, successors, agents and assigns in respect of, and forever release them from, all liability for economic loss and physical or mental injury, direct or indirect, arising in connection with the trip and the actions of any third party service providers—including, without limitation, permanent disability and death; any emotional distress; any loss of services, financial support, aid, consortium or companionship; and any damage to or loss of property—in each case even if caused in whole or in part by the conduct, including the negligence, of Roam Travel Company, except where such loss, injury or damage is caused by reckless or fraudulent conduct on the part of Roam Travel Company or their employees, officers or directors, in which case the Traveler retains the right to sue only Roam Travel Company in respect of that conduct. Travelers further agree that they will indemnify and hold Roam Travel Company harmless in respect of any claims arising in connection with the trip made by: i) third parties, which arise from the misconduct of the Travelers; ii) the Traveler's family members, dependents or heirs; iii) third parties, which the Traveler, their estate, their family members, dependents or heirs have sued, if damages are recovered from such third parties, to the extent the third party obtains any indemnification from Roam Travel Company; except where the loss, injury, death or damage is caused by the reckless or fraudulent conduct on the part of Roam Travel Company, or their employees, officers or directors. RTC reserves the right to decline accepting any Traveler whose health or actions in RTCs sole judgment impede the operation of a trip or the welfare or enjoyment of fellow Travelers.

In addition and without limitation, Roam Travel Company is not responsible for any injury, loss, or death, or damage to property in connection with the provision of any goods or services whether resulting from, without limitation, to acts of God or force majeure, weather, quarantines, illness, disease, acts of war, civil unrest, insurrection/revolt, animals, labor unrest including strikes, criminal or terrorist activities of any kind, overbooking or downgrading of services, food poisoning, mechanical or other failure of means of transportation or travel delays, travel advisories or warnings.

Roam Travel Company will be resolved exclusively in the courts of the state of California and will be governed exclusively by California law.

The term "Roam Travel Company", "RTC", "us" and "we" refers to Roam Travel LLC, registered with the state of California.
